depose and say:

2. I own/rent (cross out the inapplicable form of residence) the premises identified above. If the premises  
are rented, I have attached a copy of the lease (or a certification from the landlord if I have not executed  
a lease with the landlord). If the premises are owned, I have attached a copy of the deed.
3. I desire to register a child by the name of \_\_\_\_\_ (hereinafter referred to as the  
“child”) in the Hawthorne School District.
4. The child is living with me in my home at the Hawthorne address listed above and is being supported by  
me, without any financial contribution from his/her parent(s) or anyone else, as if he/she were my own  
child.
5. No other person is making any financial contribution for food, clothing or lodging on behalf of the child.
6. I agree to submit additional documentation which the Board of Education may request in order to  
support the validity of the statements I have made herein.
7. I intend to keep and support the child gratuitously for a longer time than merely through the school year.
8. I shall assume all personal obligations for the child relative to school requirements, including but not  
limited to the joint and several liability, along with the child’s parent (s)/guardian(s), for any tuition  
assessed if the child is determined to have been ineligible for tuition-free enrollment in the Hawthorne  
Public Schools during any period of tuition –free enrollment which was allowed by the Board either  
partially or entirely because of this Affidavit. I shall also ensure that the child complies with all of the  
policies, rules and regulations of the Hawthorne School District and the laws of the State of New Jersey.

9. I have received a copy of Board Policy No. \_\_\_\_\_ (Non-Residents) and I have reviewed its provisions regarding affidavit students. I am aware of the Board of Education’s authority to deny or terminate the child’s tuition-free enrollment if it determines that the evidence does not support my claim that the child is eligible for such enrollment. Furthermore, I am aware of my right to challenge any such decision by the Board before the Commissioner of Education within twenty-one (21) days, as well as the Board’s obligation to maintain the child in school until my time to challenge the decision has expired or the proceeding before the Commissioner of Education is concluded.
10. This Affidavit is submitted for the purpose of inducing the Hawthorne Board of Education to accept the child as a student in the Hawthorne School District on a tuition-free basis. I state that the information contained in this Affidavit is true and accurate and acknowledge the Board of Education’s reliance upon the truthfulness and accuracy of this information. If any of the statements contained in this Affidavit are wilfully false, I am aware that I am subject to the criminal penalties provided by law for perjury and/or false swearing, and will remain subject to all other obligations and/or liabilities which I have assumed elsewhere in this Affidavit. Furthermore, I understand that I I fraudulently allow the child to use my Hawthorne residence and I am not the primary financial supporter of the child, I may be found guilty of a disorderly persons offense under N.J.S.A. 18A:38-1 ( c ).
